A Message from the Executive Chair,

The earliest records of Kent State University's Graduate Student Senate (GSS) date to 1977. Since this time, GSS has been concerned with the professional advancement, mentoring, and support provided to graduate students at Kent State. Through funds provided by the Center for Student Involvement and Division of Graduate Studies/Research and Sponsored Programming, we allocate monies to graduate students for domestic and international travel as well as provide assistance to student-focused research endeavors. Through an annual Graduate Research Symposium, we encourage collaborative research and draw attention to the diverse scholarship being conducted by graduate students at Kent State. Monthly events called GradFest enable students to meet, share stories, and network with other graduate students from across campus. Past events have been held at local parks and local establishments (e.g. 157 Lounge, Dominick's, Zephyr). Community support has been received from Guys Pizza and other businesses to provide food discounts and door prizes.

In the last several years, Graduate Student Senate has increased graduate presence on University committees, grown to host the largest collegiate research event in northeast Ohio, and funded thousands of students in conference travel and research experiences. In 2012, we introduced a black squirrel logo which is now used across campus to represent GSS.

This 1st Annual Report highlights the accomplishments of the Graduate Student Senate during the 2013- 2014 academic year. As the first edition of this report, this document also considers the broader achievements of the Senate in the context of our purpose and importance to graduate students at Kent State University. 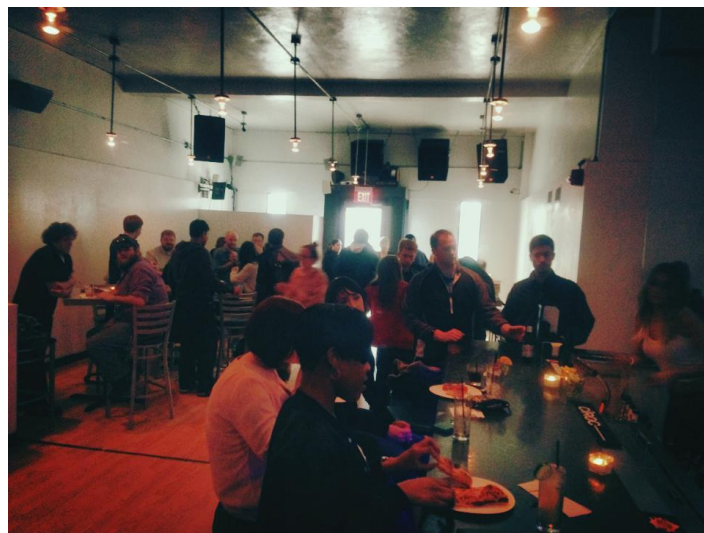
II. Executive Chair Summary

Over the years, Graduate Student Senate (GSS) has become recognized throughout the University community for our commitment to graduate students at Kent State University. We have become an instrumental component of welcoming students to campus through our involvement in Graduate Student Orientation (GSO). Through our commitment to service, many members have served on diverse committees focused on accessibility, educational policy, and higher administrative searches. Some positions permit graduate students to vote, while on other committees graduate representatives serve in an observer role, providing insight into the inner workings of an institute of higher education. This spring, graduate students were given the opportunity to talk with President-Elect Dr. Beverly Warren about graduate education at Kent State University.

Our mission is to afford graduate students with the necessary information to make their experience at Kent enjoyable and worthwhile. This mission includes dissemination of University policies, providing financial support for professional development and research, and giving graduate students a voice at the second largest university in Ohio. Our financial stability enables students to apply and participate in competitive award processes by writing and reviewing proposals. Through conference travel and professional development, graduate students at Kent State are better prepared for achievement moving forward in academic or non-academic careers. Funds are distributed to hundreds of students each year for our 3 award categories. Our annual Graduate Research Symposium has been a staple at Kent for nearly 30 years and has experienced significant growth over the last 5 years. This event provides faculty, students, and staff the opportunity to participate and witness the broad range of scholarship being conducted at Kent State. Our involvement in the community is also an important pillar of success for Graduate Student Senate. Volunteering in local shelters, collecting food and supplies for women of domestic abuse, and raising money for hurricane victims are just some examples of what we have been a part of in recent years. At monthly gatherings called Gradfest, graduate students are given the opportunity to network with each other. In all, the Graduate Student Senate provides graduate students an opportunity to be a part of Kent State University- to connect with one another, mentor incoming students, and offer a voice for graduate students.

III. Executive Vice Chair Summary

Kent State University graduate students serve as representatives on a number of university committees instrumental to the planning and operation of the institution. The primary charge of Graduate Student Senate (GSS) Executive Vice Chair (EVC) is to ensure graduate student representation on all committees that require it and/or request a graduate student representative. This includes temporary and permanent committees throughout the Kent State University campus and community. At the start of each academic year, the EVC puts out a call to all graduate students, through GSS Senators, soliciting volunteers to serve as committee representatives. The EVC then coordinates representatives' involvement and the committee reports that representatives submit after attending each committee meeting. At each GSS General Meeting, representatives may choose to present their committee reports to the Senators or they may instead choose to have the EVC present their reports to the senate body. During the 2013-2014 academic year, graduate student representatives served on the thirteen active university committees (listed below). Two of the thirteen committees have been newly added relative to the others: the University Diversity Action Council (UDAC) welcomed graduate student representation beginning in the Fall of 2012, and the Accessibility Committee welcomed graduate student representation during the current academic year. GSS was able to identify representatives to serve on each of the thirteen university committees. As a result, representatives were able to inform all graduate students, through GSS Senators, about a diverse array of university events and issues, including the university's reaffirmation of accreditation process, the approval of new courses and budgets, and initiatives to enhance technological resources and transportation.

IV. Finance Chair Summary

The primary charge of the Graduate Student Senate Finance Chair (FC) is to manage the budget, allocate funds, and coordinate the award categories with other board members. With oversight from the Division of Graduate Studies, our resources are allocated by panels of graduate students.

A. Domestic Travel Award

Description: A non-competitive travel award that supports research and the professional development of Kent State University graduate students. This award funds 50% (up to \$350) of student-incurred travel expenses to the United States, Canada, and Mexico. The Domestic Travel Award is offered fall, spring, and summer semesters of each academic year. Full- and part-time graduate students whose departments are in good standing with GSS are eligible for the Domestic Travel Award once per academic year.

B. International Travel Award

Description: The purpose of this award is to promote the professional development of Kent State University's graduate student community, to support diversity by allowing students the opportunity to immerse themselves in foreign cultures, and to extend Kent State University's recognition on an international level by providing financial assistance for international networking, research, and professional development. This award funds up to \$1,500 of student-incurred travel expenses outside the United States, Canada, and Mexico. The International Travel Award is offered fall, spring, and summer of each academic year. Full- and part-time graduate students whose departments are in good standing with GSS are eligible for the International Travel Award. See Research Symposium Chair section for specific information on this award.

C. Research Award

Description: A competitive award that supports research endeavors of Kent State University graduate students. This award funds up to \$2,000 of research related expenses. The Research Award is offered fall and spring of each academic year. Full- and part-time graduate students whose departments are in good standing with GSS are eligible for the Research Award. The Research Award can be used for data collection, analysis, and equipment. It cannot be used for travel to conferences, as other award categories fulfill that need. See Advocacy Chair section for specific information on this award.

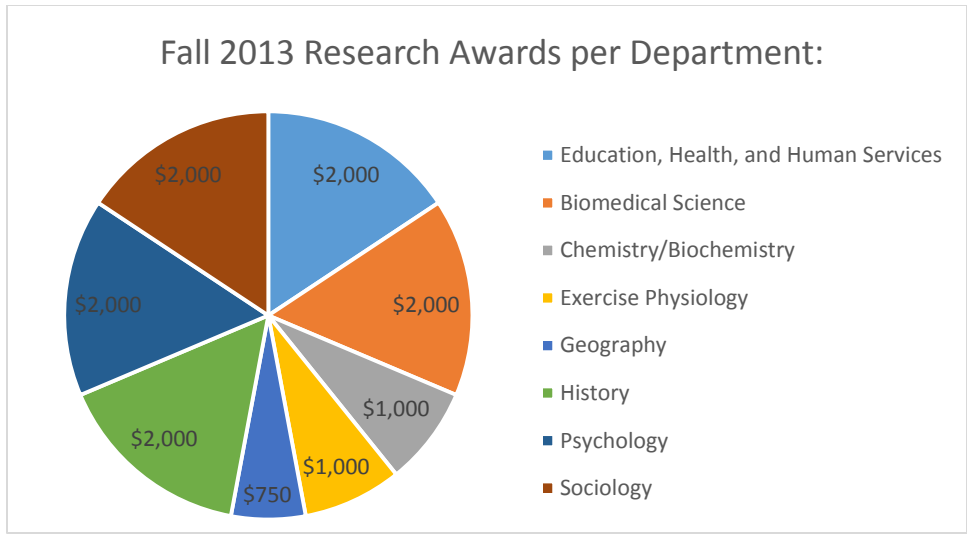
V. Advocacy Chair Summary

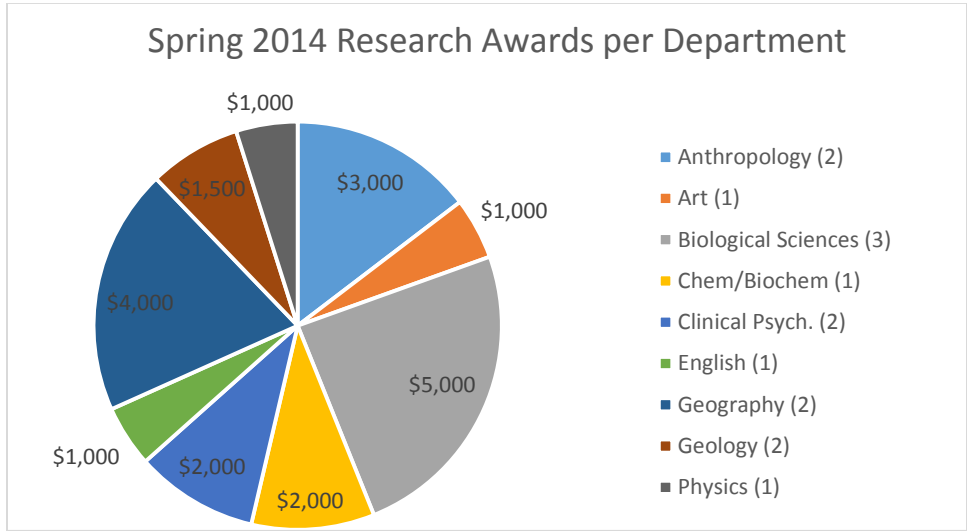
A. Research Award

Graduate Student Senate Service Initiative:

Paws and Prayers Goods Drive: November 5th through December 6th, 2013

Through the University, GSS is a 501c3 organization. Senators promoted a goods drive across the University to benefit various shelters and organizations. Students collected and donated dog and cat food, toys, beds, and treats, among other goods.

About Paws and Prayers: The group is made up of dedicated foster homes that care for orphaned dogs and cats until forever homes can be found. Their mission is to rescue, rehabilitate, and re-home unwanted dogs and cats; to prevent overpopulation through spay/neuter; to restore dignity, trust, and quality of life for neglected, abused, and homeless dogs and cats; to find the best home for each dog and cat in their care; to educate adopters and the community on pet care, spaying/neutering, training, and suitable animal selection for their lifestyle; and to provide a network of resources, volunteers, and fosters for animals, animal shelters/pounds, and the community.

VI. Research Symposium Chair Summary

The primary charge of the Graduate Student Senate Research Symposium Chair (RSC) is to organize the annual Graduate Research Symposium, which is held each spring at Kent State University. The purpose of the Graduate Research Symposium is to display, recognize, and celebrate research and scholarship across all disciplines. This event is a wonderful opportunity for both graduate and undergraduate students to gain experience presenting in an academic setting, receive interdisciplinary feedback regarding their work, network with faculty and peers, and earn a mark of distinction for their resume or curriculum vitae. The Research Symposium includes oral and poster presentations as well as an Awards Luncheon with monetary prizes given to the best presentations in each category. The second task of the RSC is to coordinate the International Travel Award (See Finance Chair section for description).

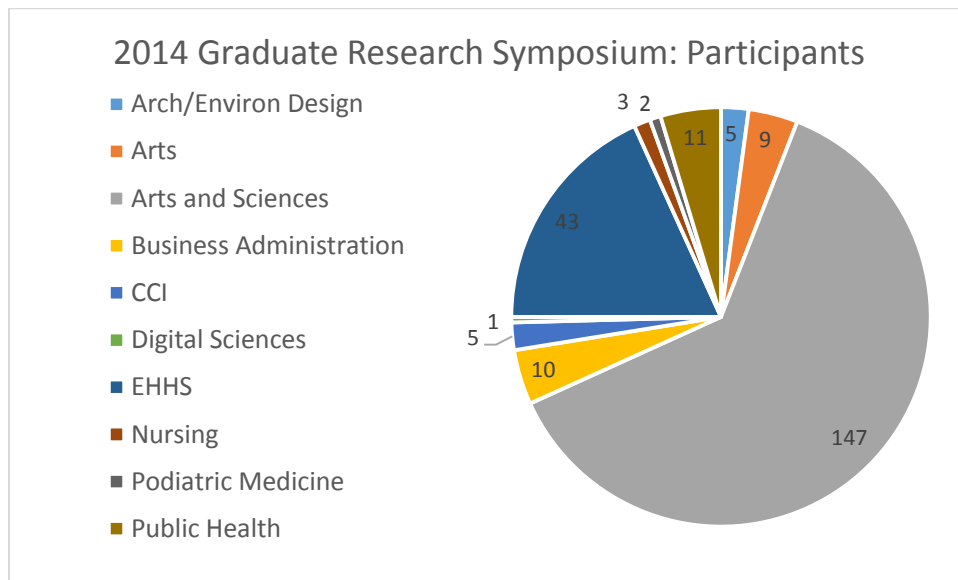

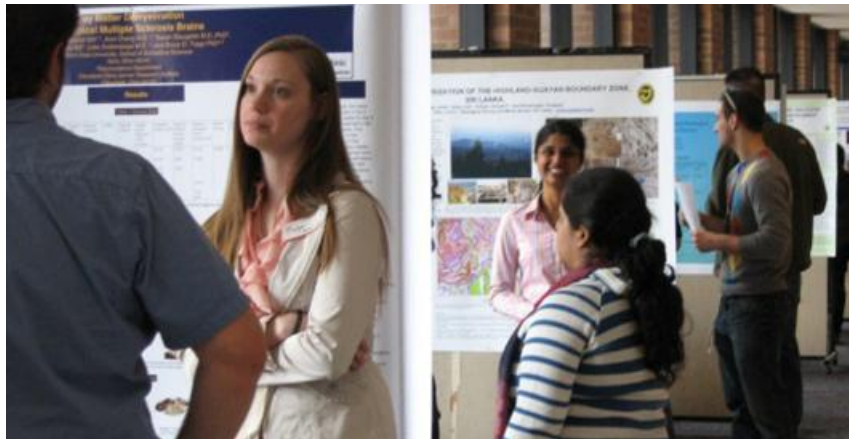
